3. We submit our report as under:

3.1 The E-Voting / Postal Ballot Process remained open from Wednesday, 10th February, 2015 to 11th March, 2015.

3.2 The Company completed the dispatch of Postal- Ballot forms on 04th February 2015 along with postage pre- paid business reply envelope to its Members whose name appear on the Register of Members as on "Cut Off" date as at 23rd January, 2015.

3.3 Particulars of all the Postal Ballot forms received / E-Voting confirmations from the Members have been entered in the register separately maintained for the purpose.

3.4 The Postal Ballot forms were kept under our safe custody in a sealed and tamper proof ballot boxes before commencing the scrutiny of postal ballot forms.



- 3.5 The Postal Ballots were opened on **12th March, 2015** in our presence.
- 3.6 The Postal ballot forms were duly opened in our presence and scrutinized and the Shareholding was confirmed with the Register of Members of the Company as on **06th March, 2015**.
- 3.7 All Postal Ballot forms / E-voting confirmations received up to the close of working Hours on **11th March, 2015** the last date and time fixed by the Company for receipt of the forms were considered for our scrutiny.
- 3.8 Envelopes containing Postal- ballot forms / E-Voting confirmations received after closing hours of **11th March, 2015** were not considered for our scrutiny.
- 3.9 Envelopes containing Postal Ballot forms which were returned undelivered were not opened and they were separately kept.
- 3.10 We have not found any defaced or mutilated ballot paper.
- 3.11 We have downloaded the data of E-voting after E-voting module was closed by Central Depository Services (India) Limited (CDSL) on **11th March, 2015** at 5.00P.M.
4. The Postal Ballot forms and other related papers / registers and records shall be delivered for safe custody of the Company Secretary of the Company who is authorized by the Board to supervise the Postal – Ballot process.
